The internship will take place in the United Kingdom, in the cities of London and Edinburgh (Scotland).

The main directions and priority topics that will be covered during this event include:

1. The UK Judicial System:

- Visits to the Supreme Court of the United Kingdom, Judicial Committee of the Privy Council, Royal Courts of Justice, Old Bailey, and other key courts of all instances.
- Review and participation in court sessions, which will provide a deeper understanding of the workings of English courts.

2. English Contract Law:

- A proprietary course led by Dr. R.M. Khodykin, a partner at Bryan Cave Leighton Paisner LLP.
- Course topics include the main features, conclusion, termination of contracts, consequences of breaches, dispute resolution, and limitation periods under English law.

3. English Notary and Legal Profession:

- Lectures and presentations by leading lawyers and notaries of England and Wales.
- Overview of becoming a notary in the UK and global prospects.

4. Barrister Practice and Traditions:

- Visits to Inns of Court and a lecture by barrister James Couser on the history and development of the barrister profession, the art of courtroom debates, and modern approaches, including ethical issues for lawyers.

5. Legal Education and Career:

- A lecture by the head of the library service of The Law Society on the codification and history of the Society of Lawyers of the United Kingdom, providing a unique opportunity for experience and knowledge exchange with practicing lawyers.

6. Communications and Reputation in the Legal Field:

- Presentation and lecture by Montfort Communications partners on "Reputation and Communication Issues in the Legal Field, in Dispute Resolution, and Interaction with Parties."

7. Legislative Processes:

- Visits to the UK Parliament and the Scottish Parliament.
- Lectures on the legislative process, interaction with committees, and international aspects of the legislative system.

The purpose of the program is to provide participants with a deep and comprehensive understanding of the UK legal system, its legislation, judicial practice, and the peculiarities of professional activities in the legal field.

Currently, ongoing reforms in the country's judicial system, the development of administrative justice, the opening of family courts, the establishment of the Constitutional Court of the Republic of Kazakhstan, active work of the AIFC, issues of mediation and conciliation procedures in and out of court, the role of lawyers in justice, expansion and digitalization of notarial activities, new standards of legal education (dual degree-dual jurisdiction) require new knowledge and the implementation of best practices from developed countries, including the United Kingdom.

At the end of the program, participants will receive an accredited certificate equivalent to 72 hours of Continuous Professional Development (CPD), recognized in any jurisdiction.

Knowledge of English is not mandatory.

Administrative costs for organizing the internship are 1,336,000 tenge (installment options available through Forte Bank), which include:

- Organization of the internship program from June 30 to July 7, 2024;
- Mini-courses with presentations on the basics of Anglo-Saxon law and English terminology by W&A Law;
- Translation services during visits to institutions and organizations;
- Excursions and accompaniment throughout the program period;
- 7 nights in a five-star hotel with buffet breakfasts, a fitness room;
- Airport transfer and return;
- Tickets for the high-speed National Railways train to Scotland and back with breakfast;
